



EZ PAY CONTRACT

1. Lin-Gas, Inc., offers our qualifying customers a monthly payment program for their propane gas bills. To qualify:
 - Your credit must be approved by us
 - You must be an auto fill customer
 - You must agree to and sign the Lin-Gas Bulk Propane System Lease
 - You must have a tank fuel monitor installed and operating so we can be certain you will not run out of propane when you need it.

With all this complete, you will receive the auto-fill price discount, a monthly payment for your propane bills and the best assurance available with the use of your tank monitor that you will always have a supply of propane.

The E-Z Pay program will estimate your propane usage for the forthcoming year, the price of that propane and then divide that by the 12 months in the year. This gives us an estimate of your monthly payment for those 12 months. If that changes, we will notify you of any adjustments. If, because of your usage or the price of propane that number increases, you will adjust your payment accordingly to avoid falling behind and being dropped from the E-Z Pay program. At the end of May of the next year, we will "settle up" after calculating your total charges and how much you have paid. You will either pay any balance or instruct us to refund or apply any credit balance you have towards next years E-Z Pay program.

2. The E-Z Pay program starts June 1st, so be certain to return the complete agreement to us with your signature and all the information requested before then. If you have any questions, please contact us at the Evansville office at 812-424-9021 or 800-850-4380.
3. This program is subject to cancellation if any of your regular EZ Pay monthly payments are not made, in full, by the 15th day of each month. In such event, your automatic gas fills will be discontinued and you will lose the benefits of the EZ Pay Program. You will become a Will Call customer.
4. This EZ Pay Program Agreement will continue in effect until we receive written notice from you to cancel or we give you a written notice of such cancellation. Such notice will be effective five days after we mail it to you. Either you or Lin-gas may cancel your participation in the EZ Pay Program.
5. To the extent that the terms of the Bulk Propane System Lease Agreement are inconsistent with this EZ Pay Program Agreement, the terms of this EZ Pay Program Agreement shall govern. All other terms of your Bulk Propane System Lease Agreement shall remain in full force and effect.
