FESTIVAL PROPANE FUEL AGREEMENT - OCTOBER 3 - 8, 2011

_____ (Customer) wants Lin-Gas, Inc., to provide propane fuel in cylinders for use at the Festival. Lin-Gas, Inc. will provide and install filled propane cylinders to Customer's site, for its use during the Festival. Lin-Gas will make deliveries when we receive an order from your organization's representatives.

Lin-Gas, Inc., will service the Lin-Gas' equipment at Festival and Customer is neither to tamper with this equipment nor allow anyone else to do so. Please do not let anyone else work on or service our equipment. This could create a hazard for everyone and you promise not to do that. If Customer wants Lin-Gas, Inc., to work on Customer's equipment, there will be an additional charge for parts and labor, which Customer agrees to pay.

Customer must comply with all laws and the instructions of any governing authority that may have jurisdiction over the Festival. This means that the fire department (and others) may inspect your installation and equipment to be certain it is safe and may tell you to do something. You must follow their instructions. Contact us if you require service from our technicians.

Lin-Gas, Inc., will also provide you with safety information about propane entitled "If You Have a Propane Leak dated 090111" - please read it). Remember that propane is heavier than air, smells like rotten eggs and is extremely flammable. If you don't understand, ask us.

You agree to read and make certain that anyone else at your location is familiar with the characteristics and the hazards of propane and that they read all safety information. If you have a problem, immediately turn off the valve on each tank and contact us at 424-9021 or the fire department (911).

Lin-Gas, Inc., provides the propane, in cylinders, to Customer, together with an invoice and Customer agrees to pay Lin-Gas, Inc., for this service. Customer will return ALL Lin-Gas cylinders at the end of the Festival. In order to do that, you have to tell us the following:

5. If you know your site location at the Festival, tell us now _____

We will bill you after the Festival, but will want you to pay us right away (15 days) after we mail the bill to you. After 15 days your account will be past due and interest at 1 1/2% per month will be assessed until your account is paid in full.

If you agree to all of this, sign and date in the place provided below, mail it to us (we've enclosed an envelope for you) and we will take care of the propane supply so you don't have to worry. Be certain to make a copy of this agreement (both pages or sides) for your records or tell us and we will make a copy and mail it back to you. This agreement will remain in force and effect until you or we give the other notice to terminate it. This Agreement incorporates the terms, obligations and instructions of Lin-Gas' If You Have a Propane Leak dated 090111 found on the reverse side or 2nd page of this Agreement and is hereby incorporated by reference.
