



Automatic Bill Payment

Paying your Lin-Gas bill has never been more convenient.

You'll never have to write a check, use a stamp, or make an extra trip to the mail box when you sign up for Lin-Gas Automatic Bill Payment. And it couldn't be easier or more convenient to use. Each month, your payment is automatically deducted from the checking, savings, or credit card account that you select.

Automatic Payment gives you one less thing to worry about.

Once you're enrolled, you'll never have to worry about paying your bill, whether your payment is late, whether or not you signed the check, or anything else for that matter - because everything is taken care of automatically.

Here's how it works.

You'll receive a statement from Lin-Gas, listing your charges and noting "Automatic Pay," along with the scheduled date on which your account will be charged. You'll have about ten days to review your statement, and to call us with questions. And each month you'll be able to see your Lin-Gas payments reflected on your selected bank or credit card account statement. It's that simple.

Signing up is easy.

To sign up, simply return the completed application. If you prefer to have your charges come out of your bank account, please be sure to include a blank, voided personal check or withdrawal slip from your designated account for verification. You'll know you're enrolled when the words "Automatic Pay" are printed on your Lin-gas statement. If there are any changes to your bank account or credit card, please let us know. LIN-GAS, INC. AUTOMATIC BILL PAYMENT PLAN OPTION TERMS AND CONDITIONS

By agreeing to preauthorized transfers, you agree with Lin-Gas, Inc. as follows:

Lin-Gas will provide you with a statement of your account containing an itemized list of charges made during the billing period. You will receive this statement not less than ten days prior to the date your account will be debited. You agree to review each statement you receive for any errors. Under federal law, you have the right to halt and electronic fund transfer provided you give your financial institution notice in a timely fashion. If you inform Lin-Gas that an error exists on your statement, Lin-Gas will attempt to correct that error prior to your next statement. Lin-Gas shall bear no liability or responsibility for any losses of any kind that you may incur as a result of that erroneous statement or due to any delay in the actual date on which your account is debited.

If any changes occur in the information you provide on your application, you must immediately notify Lin-Gas in writing of such changes. If your credit card is lost or stolen or expired, you must provide Lin-Gas with current credit card information.

If you do not notify Lin-Gas in writing of such changes or do so in an untimely fashion, Lin-Gas shall bear no liability or responsibility for any losses incurred. Lin-Gas's sole liability to you shall be Lin-Gas's obligation to make any appropriate changes once in receipt of your written notification. The statement date of the withdrawal of funds from your

account and the date we actually withdraw those funds may vary up to the (10) business days after, but never before, the withdrawal date set forth in your statement. Lin-Gas reserves the right to change these rules at any time. Either party may terminate this agreement at any time by giving the other party written notice reasonably in advance of the date of termination or any scheduled settlement date (but in not less than 30 days). Termination shall not prevent a debit transaction authorized before any notice of termination.

You agree to be bound by any rules your financial institution requires for preauthorized electronic funds transfers.
